#### **UPDATE FROM THE COUNCIL:**

#### • FORESHORE MASTERPLAN

Playground upgrade completed. The new fenced playground is now completed and being enjoyed by local and visiting families with the installation of new equipment and seating for parents. LCPA and local residents thank PMHC for this work and the start of upgrade to the Foreshore Masterplan facilities. We expect the next project to be the installation of a new toilet block closer to the carpark, and the demolition of the old block. LCPA will advise members and the community when more information becomes available for PMHC.

#### ILLAROO ROAD STORMWATER REDRECTION

Council is proposing to undertake construction works to redirect stormwater flows along Illaroo Road. At present, stormwater infrastructure directs runoff onto the Beach via 2 stormwater outlets. These existing outlets pose risk to erosion of the beach foredune and subsequent potential undermining of Illaroo Road. It is proposed to construct new stormwater infrastructure (pit & pipe system) along Illaroo Road to direct stormwater runoff to the northern end of Illaroo Road, and discharge into the lake. The NSW Government's Coastal and Estuary Grants program has allocated \$360,000 to reduce beach erosion to the foredune system.

#### • MEETING WITH MAYOR

LCPA are scheduled to meet with Mayor Pinson and senior executive early in December, a report back to our members will be provided in the New Year. Topics for discussion at this meeting are;

- o When is Council proposing to start storm water redirection along Illaroo Road?
- o Will funding become available for the construction of the Revetment wall prior to 2021?
- At what step in the process of the DA application for stage 1 of the Foreshore Masterplan currently at.
- Has council been successful in obtaining grant funding for the replacement of Fish Cleaning tables in Jabiru Park and at the Fishing Platform?
- What is the current status of draft plans released to the public on Ocean Drive Upgrade?
- Has Council considered lobbying the Stat Govt. and Health Dept. to include a new Ambulance and Fire Station in the Area 14 Development?
