Lake Cathie beach south of Kywong Street with coffee rock exposed

"The recent big seas and high tides removed about a quarter of the 20,000 cubic metres of sand recently pumped from the estuary and spread in front of Illaroo Road. Sections of coffee rock along Chepana Street, which have been fully covered with sand in recent years, were also exposed.

How lucky we are having the coffee rock along our beach front to reduce the rate of erosion and damage from big seas and king tides. Images we see of Old Bar beach, where coffee rock is not present, really illustrate our good fortune.

This confirmation of the erosion resistance of the coffee rock should finally satisfy Council staff, from whom Chepana Street property owners have sought removal of the erosion risk notations on S.149 certificates, appearing since 2008.

How long will it be until the sand returns is a matter for nature to answer, but it will happen, as it always does."
