Lake Innes Project scope disappoints Lake Cathie residents with Estuary issues excluded

Having read the brochure mailed out with their Rates Notice Lake Cathie residents are extremely disappointed to find the Lake Innes Management Investigation Project excludes all reference to their Estuary system.

No previous Lake Innes Study

The Progress Association is not aware of any previous detailed study on Lake Innes while it is open to the sea. This data is essential to understand the environmental, social and economic impacts of the possible reversion to freshwater and will be collated by the Contractor.

From information included in the Project brochure the recommendation on whether or not to revert Innes to freshwater will be based on the Lake Innes data only.

However community members expected the Investigation would also update data from the previous Estuary studies and come to recommendations based on the combined Innes and Estuary data.

Studies recommend Lake Innes & Cathie Estuary return to their natural configuration

Prior to 1933, when Lake Innes was opened to the sea against all expert advice, the system operated successfully and all studies since 1983 recommend this status should be restored as additional water flows would improve flushing of the system plus other benefits to the Estuary & coast.

The heavy siltation of the tidal channels and growth in the size of sand islands are now so bad that a three day survey of residents in February 2012 reported 370 in favour of dredging west of Ocean Drive Bridge with 1 against.

Such is the community feeling on this issue that residents, frustrated by the lack of action, believe any further studies will just be a waste of time and money.

The Investigation is funded by almost \$1 million from the Commonwealth Government and is led by the Northern Rivers Catchment Authority.

Power poles moved to allow Ocean Drive cycle lanes

In April's Cathie News we ran the story on our efforts to have Council construct the missing section of cycle lanes on Ocean Drive north of the village.

Council advised that a number of power poles needed relocation to allow space for the cycle lanes.

On July 6 Council advised Essential Energy had completed relocation of the poles and Council is now in a position to finalise design and cost estimates and investigate funding options.

We'll keep you posted.

Huge increases in home insurance

One resident reported a premium increase of almost 160% with his premium increasing from about \$750.00 to almost \$2000.00.

The Association checked with Council for any amendments to the Flood Plan for the area and was advised no changes had been made.

We then discussed the matter with some of Port Macquarie's leading insurers and were told this action by some insurers was occurring on a regular basis. They believed the insurers were reacting to the massive claims resulting from floods in Queensland and other States and possibly the Victorian Fire disasters.



Voting methods for new Councillors need explanation

There will be two voting papers for the September election. One will be for the position of Mayor and the second for nine Councillors.

The voting paper for Councillors will be the ABOVE THE LINE and BELOW THE LINE format.

This type of voting paper requires detailed explanation of how to complete the form to meet your voting preferences.

We believe the detail on how to complete this form will be widely covered by Council and the local Press prior to Election Day. We strongly recommend residents study and understand how to complete this form before going to the polling booth.

Above the Line Group voting not favoured by Progress Association

The Association has concerns that if a group of Candidates succeeds in having all its members elected this could lead to control of voting on Council matters and not take the broader views of all residents into consideration.

In fact the Association does not support political parties or other groups operating in Local Government management for the same reason.

The Association will recommend to its members to vote BELOW THE LINE for individual Candidates of their choice.

Ratepayer poll on Glasshouse supported by residents

The article in the June edition of Cathie News for a poll brought many positive responses from the community. Almost all local residents believing the continued operation of the Glasshouse benefits those in Port CBD and causes financial hardship for other parts of the LGA.

Some candidates for the September election have stated the Glasshouse should continue to operate as is.

Since Ernst & Young's 2010 report on operation of the Glasshouse the Progress Association has stressed that \$6 million dollar losses may be OK for a couple of years but continuing to incur losses of this size is unsustainable for any business.

For instance the accumulated **loss over fifteen years will total about \$90 million**. This cannot be allowed to occur.

Ernst & Young's 2010 market appraisal

Ernst & Young reported the building had a market value of \$18 million but recommended against a sale as Council would need to write off \$27 million. In other words the asset is on Council's books at a value of \$45 million but is only worth \$18 million.

Accountants tell us the practise of showing an asset value above its market valuation would not be allowed in commercial businesses. However the accounting rules of Local Government allow such practices.

If the building sold for \$18 million and this amount paid off the Glasshouse loan it would substantially reduce loan repayments and interest charges as well as eliminate the year after year \$4 million (approx) operational losses.

The Association will be pressing the new Council to compile a ten (10) year financial statement based on the sale of the building. It is probable this statement will show that in a few years the loan would be paid out and with that all interest charges eliminated with no ongoing loss of revenue to Council.

Options for Ratepayer Poll on Glasshouse

A ratepayer poll should include the following for residents to determine future management of the business:

- 1. Continue to operate the Glasshouse as is -a ten (10) forward statement of profits/(loses) included.
- 2. The sale of the building and Council to cease operation ten (10) year financials included
- 3. Other options for continuing operation of the Glasshouse ten (10) year financials included.

While the poll would have a cost the amount would be minor compared with the millions of ongoing annual losses under the present operating structure.

Lake Cathie Erosion Management Plan

It is expected Council will move ahead with the Lake Cathie Coastal Zone Management Plan in the near future.

This follows Council's July meeting at which the proposal for a revetment along a section of Illaroo Drive and to undertake beach nourishment (pumping sand from the estuary lagoon) were adopted.

The Progress Association lodged a 17 page submission supporting the revetment and beach nourishment and an amazing 4500 public submissions also supported this option.

The design, planning and sources of funding for the work will now commence.

We understand that until the revetment is built the affected properties will continue to be subject to planning controls as noted on their 149 Certificates. However some relaxations were allowed for owners to conduct minor additions and alterations to their properties.

Homeowners in Chepana Street are negotiating with Council to have their 149 Certificates cleared of the conditions as a matter of urgrency.

Coastal Legislation complexities

Cathie News has been running articles on the failings of this Legalisation since it was passed by the previous Government in 2011. Is hoped the amendments to the flawed Coastal Protection Bill are completed in a timely manner so as not to delay this phase of the planning for construction of the revetment.
